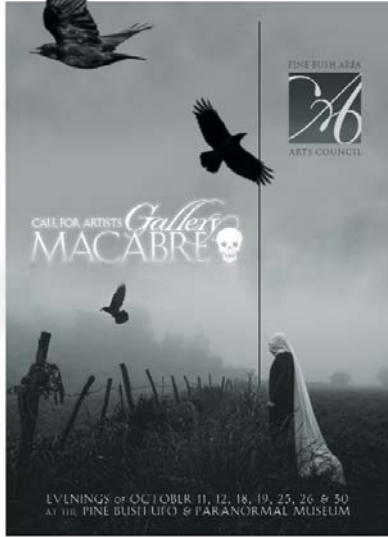

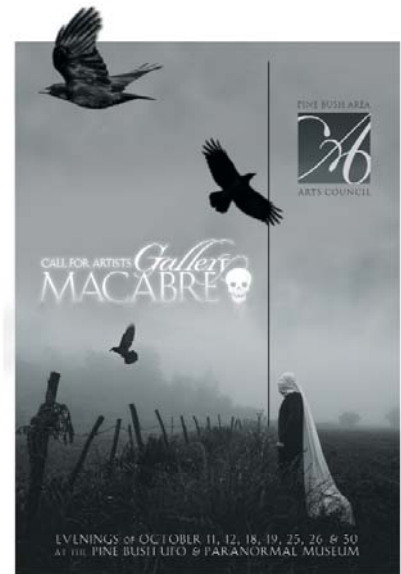

## Gallery Macabre Show Rules and Regulations

*Please read thoroughly before signing and submitting your application form.*

- The Pine Bush Area Arts Council reserves the right to refuse to accept any artwork based on content, operational and space requirements. Content should be suitable for display in a public setting.
- Artwork must be original. A reproduction of the artist's original art is eligible for submission. Art made from kits, ceramics that are not self-poured or similar means will not be accepted.
- Artwork must be suitably framed, and/or ready for hanging/display.
- Exhibition site is the Pine Bush UFO & Paranormal Museum, at 86 Main Street, Pine Bush, NY 12566 during the *Gallery Macabre* event.
- Days of the exhibition are the evenings of October 11th, 12th, 18th, 19th, 25th, 26th and 30th, 2024.
- Exhibition hours are 7:00 to 9:00 pm and are subject to change.
- Exhibition fee for one artwork is \$5.00 or three (3) artwork for \$10.00. More than three (3) works may be submitted for consideration.
- Selection and space will be assigned by PBAAC and the Museum. Their decision is final.
- Intake of art will take place at the Pine Bush UFO & Paranormal Museum, 86 Main Street, Pine Bush NY on Monday, October 7 between the hours of 5:00 and 7:00 pm or on Tuesday, October 8 between 3:00 and 5:00 pm, unless arrangements are made in advance.
- Artists must have completed, signed application and waiver forms and make fee payment at the time of submission. Incomplete applications will not be considered.
- The sale of artwork is permitted. Artists are responsible for obtaining all licenses and certifications required by local, state or federal law and the collection of any applicable sales tax on items sold. Sale transactions will be conducted by the artist. Purchasers will be directed to contact the artist to arrange payment and terms. Art may also be marked as "not for sale."
- Artwork must remain on display through the event's closing date. At the conclusion of the show, art must be picked up no later than 4:00 pm Sunday, November 3, 2024, unless arrangements are made in advance.
- Artists are advised to obtain such insurance coverage as they deem necessary for their protection and the protection of their art against damage or theft.
- Please make copies of your completed and signed forms for your records. At submission, please have your payment for the appropriate exhibition fee and the completed original, signed application and waiver forms ready.
